### 5. APPLICATIONS

5.1 <u>25/01021/PA</u> - Prior Notification for Larger Home Extension (part 1 class A): Single storey flat roof rear extension to a depth of 8m, maximum roof height of 2.10m, and eaves height of 2.60m - 23, ASHLEY ROAD, HILDENBOROUGH. Deadline date 25<sup>th</sup> August 2025. **Leave to the discretion of the planning officer.** 

**5.2** 25/01249/PA - Section 73 application varying the wording of condition 3 (approved plans and documents) to regularise the works of Planning application TM/23/03219/PA Demolition of existing outbuildings and replacement with new gym/pool room, garages and partial infilling of swimming pool -ROUGHETTS, COLDHARBOUR LANE, HILDENBOROUGH. Deadline date 25<sup>th</sup> August 2025. **Leave to the discretion of the planning officer.** 

- **5.3** 25/01254/PA Consultation by Sevenoaks District Council: Variation of conditions 2, 3, 5, 9,10 & 12 of 22/00026/CONVAR to modify consent to include domestic pet cremations (Sevenoaks DC reference: 25/01928/CONVAR). Sparrowhawks Equine Crematorium, Sevton Farm, Powder Mills, Leigh. Deadline date 25<sup>th</sup> August 2025.  **No comment**
- **5.4** <u>25/01277/PA</u> Proposed removal of existing Dormer with first floor side extension. Demolition of existing conservatory, and construction of a part single/part two storey rear extension. COURTYARD COTTAGE, COLDHARBOUR LANE, HILDENBOROUGH. Deadline date 25<sup>th</sup> August 2025. Leave to the discretion of the planning officer.
- 5.5 25/01291/PA Section 73 Application for the removal of conditions 4 and 5 (permitted development rights restriction) relating to planning approval TM/11/03278/FL Fairhill Court Riding Lane Hildenborough. Deadline date 1st September 2025. The Parish Council Planning Committee objects to the proposed removal of Conditions 4 and 5 attached to planning approval TM/11/03278/FL. These conditions remain necessary to protect the rural character and residential amenity of the area. The site has not materially changed since the original approval, and the removal of these conditions would undermine the planning restrictions intended to ensure appropriate development in this location.
- 5.6 25/01251/PA Lawful Development Certificate Proposed: Extension of existing dropped kerb 35, CORRENDEN ROAD, Tonbridge. Deadline date 1st September 2025. Submit image The Parish Council are concerned that the proposed extension would set a precedent for excessively wide dropped kerbs in the area. It would reduce available on-street parking for other residents. There are utilities present within the footway that may be affected by the proposed works. The Parish Council is not aware of any consultation with Kent County Council Highways, who must be involved in any alterations to the public highway.
